Treatment Court Program Status


As of Jan. 31, 2012, there were 141 treatment court programs: 89 adult, 13 juvenile, 14 family, 21 designated DWI, 1 reintegration, and 3 veterans courts serving 8 counties. The commission provided funding to 50 treatment court jurisdictions that include 131 treatment court programs.

Participants

As of Jan. 31, 2012, there were 3,322 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans and adult drug courts unless otherwise noted.


Total Participant Trend




Admissions

There were 203 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2012 is 203. Re-entry also includes reintegration case types.

Exits

Termination includes termination, voluntary withdrawal, administrative discharge and dismissal docket types.

As of Jan. 31, 2012, there have been a total of 11,163 treatment court graduates.

A total of 595 babies have been born to female participants during treatment. **547 of these have been born drug free.**

- Six drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed babies were born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
