Treatment Court Program Status


As of Feb. 28, 2011, there were 128 operational treatment courts: 85 adult, 16 juvenile, 13 family, 12 designated DWI, 1 veteran and 1 reintegration. The commission provided funding to 50 treatment court jurisdictions that include 125 operational treatment courts.

Participants

As of Feb. 28, 2011, there were 2,998 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration and adult drug courts unless otherwise noted.


Total Participant Trend




Admissions

There were 147 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2011 is 320. Re-entry also includes reintegration case types.

- The average age at admission was greater than 31 years old.
- Admissions range in age from 17 to 58 years old.

Exits

Termination includes termination, voluntary withdrawal, administrative discharge and dismissal docket types.

As of Feb. 28, 2011, there have been a total of 10,056 treatment court graduates.

A total of 547 babies have been born to female participants during treatment. **500 of these have been born drug free.**

- 1 drug free baby was born to participants that exited treatment court during this reporting period.
- No drug exposed babies were born to participants that exited treatment court during this reporting period. This is three consecutive reporting periods in which no drug exposed babies were born.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
